# Establishment of the Sustainability Standards Board of Japan (SSBJ) and Formation of the SSBJ Preparation Committee

The Financial Accounting Standards Foundation (FASF) announces the establishment of the Sustainability Standards Board of Japan (SSBJ) and the formation of the SSBJ Preparation Committee.

### 1. Establishment of the Sustainability Standards Board of Japan (SSBJ)

In November 2021, the IFRS Foundation announced the establishment of the International Sustainability Standards Board (ISSB) to develop international sustainability disclosure standards. Stakeholders in Japan expressed the need to contribute to the development of international sustainability disclosure standards and to develop domestic sustainability disclosure standards.

In this context, on December 17, 2021, the Board of Directors of the FASF passed a resolution to establish the Sustainability Standards Board of Japan (SSBJ).
